# CUMRU TOWNSHIP BOARD OF COMMISSIONERS REGULAR MEETING APRIL 18, 2017

The Regular Meeting of the Cumru Township Board of Commissioners was called to order by President Ruth O'Leary at 7:01 p.m. Other Commissioners in attendance were Sheri Hoover, Tony J. Sacco, and Lorri K. Swan. Vice President Edward L. Gottschall was absent with prior notification to the Board. Also attending were Chief of Police Madison Winchester, Fire Chief James A. Beane, Superintendent of Public Works Robert McNichols, Jr., Manager Jeanne E. Johnston, and Secretary Latoya Procopio.

#### **PUBLIC**

<u>Attendance:</u> William Miller of 40 Muirfield Drive, Joe and Nicole Schaeffer of 17 Mohnton Lawn Court; James Williamson.

Mr. William Miller of Muirfield Drive introduced himself to the Board of Commissioners as well as to the audience. He stated that he will be a write-in candidate for Cumru Township Commissioner.

Joe and Nicole Schaeffer explained to the Board that they are concerned about the noise level in their neighborhood, which started back in February 2017. They stated that their neighbor is riding a dirt bike during the week and weekend afternoon hours. Mr. Schaeffer stated that they called the police and spoke with Officer Griffith, who stated the Township did not have a noise ordinance. Mr. Schaeffer stated that the noise is so loud that he is unable to hear the TV. Ms. Schaeffer stated that the person rides the dirt bike every day after 3:00 pm until dark and all day on the weekends. The other neighbors have expressed their annoyance, but refuse to complain.

Ms. Johnston informed Mr. and Mrs. Schaeffer that the Township does have a noise ordinance, but it is difficult to enforce the noise levels in a situation like this. Mr. Setley stated that the nuisance ordinance may be more enforceable.

## Police Department

# A) Monthly Report – March 2017

Chief Winchester informed the Board that the past weekend was very busy for the police department. He stated that there has been recent activity on Misty Lane involving domestic violence and theft. In addition, Officer Wertz investigated a parked car at the Gateway building and discovered the driver, unconscious with drug paraphernalia and a stolen gun. Chief Winchester also told the Board that at 3:30 pm today a deceased man was found in a body of water by the owner of the property. The deceased man is believed to be from out of state, but identification is being withheld pending notification of relatives.

## **B) Civil Service Commission- Police**

1) Memo from Chief of Police re: certified list, dated 4/12/17

ON MOTION OF MRS. HOOVER, SECOND OF MR. SACCO, A UNANIMOUS VOTE ACCEPTING THE CERTIFIED LIST, AS RECOMMENDED BY THE CIVIL SERVICE COMMISSION.

# C) Police Department – Recommendation to hire

Chief Winchester requested to Board consider hiring three probationary police officers from the Civil Service Commission List; the Civil Service Commission recommended hiring three. Background checks will be performed on the top 6 names on the list. Chief Winchester stated that two hires with Act 120 certification would replace two recently retired officers and a third hire would be the beginning of succession planning, since two officers are currently in the deferred retirement program and one officer has announced he will be retiring at the end of 2017. The Board questioned if the money to pay for these new hires was in the budget. Chief Winchester stated that two officers were budgeted and the Township would be reimbursed by MPOETC 75% for the police academy training of the third officer. The police academy starts in July and is 6 months long. Mrs. O'Leary noted that a third hire would not be a full year of cost.

On motion of Mrs. Hoover, second of Mrs. O'Leary a motion to hire three officers, condition on successful completion of all the background checks, was made. Roll Call: Mrs. Hoover – Yes; Mrs. Swan – No; Mr. Sacco – No; Mrs. O'Leary – Yes. The motion did not carry. Mr. Sacco stated he was concerned with the third hire not being budgeted for this year.

ON MOTION OF MR. SACCO, SECOND OF MRS. SWAN, A MAJORITY VOTE AUTHORIZING THE HIRING OF 2 PROBATIONARY POLICE OFFICERS, CONDITIONED UPON SUCCESSFUL COMPLETION OF ALL BACKGROUND CHECKS. ROLL CALL: MRS. SWAN – YES; MRS. HOOVER – NO; MR. SACCO – YES, MRS. O'LEARY – YES.

Mrs. Hoover stated that she is concerned that if the Township waits to hire the third officer, the best candidates will get hired by other municipalities hiring police officers currently.

## Fire Department
